7. I agree to provide each party and counsel with CADRe post-ADR process evaluation forms and stamped, addressed envelopes as required by the CADRe program. I also agree to return a *Statement of Agreement/Non-Agreement* [ADR-100] to the CADRe office within 10 days after the final ADR session in every case as required by the CADRe office [refer CRC 3.875].

8. I agree to work professionally, cooperatively, and respectfully with the court, CADRe staff, counsel, and litigants to assist in the successful operation of the CADRe program, and to bring to the attention of the CADRe staff any issues I believe should be addressed.
